

THE 2009 -2010 AMA SPONSORED GROUP DISABILITY INSURANCE PLAN *for* PHYSICIAN ASSISTANTS

The AMA sponsored MedPlus Advantage Long Term Disability Plan provides a monthly benefit in the event you become disabled and are unable to complete your training. - If you become disabled, you are eligible for a monthly base benefit of \$1,100.
- If Totally and Permanently disabled, your eligible student loans, up to \$200,000 are eligible for repayment.
- If Totally and Permanently disabled, you are eligible for a \$5,000 lump sum benefit.
- Conversion to an individual income protection policy upon completion of UW's Physician Assistant program - without evidence of insurability.

This is your single opportunity to enroll in this coverage. Evidence of insurability is not required. Forms must be completed and submitted within 31 days of your first

day in the University of Washington MEDEX Northwest Physician Assistant Program.

Premium for this valuable program is only \$88.43 per year. That comes out to \$1.70 per week - less than you'd pay for a latte at your local coffeehouse.

Eligibility to Enroll

You are eligible to enroll in the Long Term Disability program if you are in the Physician Assistant training program at the University of Washington.

Eligibility for Benefits

If you become totally disabled (as defined in the certificate of insurance), you will receive a monthly benefit starting on the first day after a 90 day waiting period. Your benefits will continue for the rest of your life or until your disability ends. Disabilities due to a Mental Health Disorder are limited to 24 months of Benefits.
