The Board of Regents held a special meeting on Friday, January 29, 2010, beginning at 8:30 a.m. in Gerberding Hall, room 301. The notice of the meeting was provided appropriately to the public and the media.

CALL TO ORDER

The meeting was called to order at 8:30 a.m. by Regent Herb Simon.
