Application Deadline: May 29, 2009

To be considered on-time, applications must be received in the Student Parent Resource Center by 5:00pm on May 29, 2009. Childcare applications received after the **deadline of May 29th** will be considered only if funding is available. **NOTE:** First-time parents and/or newly admitted students for Summer or Autumn Quarter 2009 may apply for the 2009 – 2010 assistance through October 13, 2009. Any first-time applications submitted after this deadline will be considered only if funds are available.

Program Information:

- Student-parent applicants are considered for childcare assistance on the basis of financial income & resources, as determined by the Office of Student Financial Aid based on the FAFSA or International Student Financial Statement and I-20.
- Only student-parents enrolled (or who plan to be enrolled) at the UW Seattle campus are eligible to receive this childcare assistance. UW Bothell and UW Tacoma campus student-parents should apply at their respective campus.
- Student-parent applicants are eligible to receive childcare assistance for eligible children if they are enrolled at the UW Seattle Campus as verified by the 10th day statistics published quarterly by the Office of the Registrar. To be eligible for assistance, student-parents must pay the Services and Activity Fees.

NOTE: International students must complete and submit the International Student Financial Statement form along with a copy of their current I-20 form or other proof of income for 2009-2010.
