

University of Washington Agreement Form

Terms and Conditions

I am currently a University of Washington (UW) matriculated graduate student, faculty member or staff member. I acknowledge that undergraduates, extension students, affiliates not paid by the UW, and visiting scholars are not eligible for SPSS software under this agreement. I agree to the following:

1. Subject to the provisions contained herein, I may use the SPSS, Inc., copyrighted computer software products that the UW has provided to me in accordance with its agreement with SPSS, Inc.
2. I acknowledge that these products are copyrighted and that SPSS, Inc. retains all title and ownership rights to the products. I agree not to copy or permit others to copy the products, in whole or in part.
3. I agree to use the products under this agreement only on a computer which is 1) owned or leased by the University of Washington or 2) owned by me. I further agree that the products must remain under my control, and that resale or other transfer is explicitly prohibited.
4. I agree to use the products only for the University's own data processing requirements and not for commercial time-sharing, rental or service bureau use.
5. I agree not to create, or attempt to create, or permit or help others to create, the source code from the products furnished under this agreement. I acknowledge that reverse engineering or de-compiling the products is forbidden.
6. Should I remove the computer(s) on which the products are used under this agreement from the location specified, I agree to notify UWare Software Licensing, *uware@u.washington.edu*, promptly of the new location.
7. Upon the termination of my status as a UW graduate student, faculty or staff member, I agree to return to UWare Software Licensing or destroy at once any and all copies in my possession. I will forward written notice to *uware@u.washington.edu* that all programs and materials containing the products have been destroyed or deleted from all computer libraries, storage, and memory devices, and are no longer in use or usable.
8. A single-user license allows the installation on up to two computers, a work computer and a home computer, if those computers are used by only one user.
