Dear Colleagues,

Research is foundational for the future of the UW. We are transforming the world by providing solutions to society's most pressing issues. We are committed to enabling excellence by investing in targeted initiatives and funding strategies that support our faculty, students and staff, guided by the principles of innovation, scholarship, and discovery.

Our top rankings have been consistent, including those published by the Institute of Higher Education at China's Shanghai Jiao Tong University where the UW placed 16 among the world's top universities (a ranking held since 2007), and 14 nationally. We ranked in the top five in Life and Agricultural Sciences, and Clinical Medicine and Pharmacy. The Higher Education Evaluation & Accreditation Council of Taiwan (HEACT) ranked the UW fourth overall and first in public universities worldwide for the quality and impact of research endeavors.

Fiscal year 2013's total grant and contract awards were \$1.238 billion, tripling our research funding over the last twenty years. From 1974 - 2009 the UW received more federal research funding than any other U.S. public university, and since 2009 in the top two for receipt of federal funding. Since 1969 we have placed among the top five for total funding for all public and private universities in the country. Due to our talented faculty, as well as new research space and facilities that have come online, in the last four years our federal market share has increased 35% from 2% to 2.7%.

A significant indication of the UW intellectual community's strength is the number of grants over \$1 million, currently 43% of total awards (\$529,995 million). Highlighted here is a selection of our high impact grants over \$1 million that demonstrate the breadth and depth of our research talent, as well as strength in collaborative research:

- \$12 million from the US Department of Health & Human Services Administration for Children and Families to support the National Center on Quality Teaching and Learning (NCQTL), a multi-component national effort to reshape and raise quality in Head Start programs. The third year funding of a five-year, \$40 million grant enables UW researchers to turn current research into relevant, usable classroom practices and training materials. PI: Susan Standall; Co-PI: Gail Joseph

- \$1.95 million from the NSF/NIH/USDA to look at infectious disease in Pacific salmon. PI: Kerry-Ann Naish
- \$1.9 million (\$9.6 million over five years) from the NASA Astrobiology Institute for development of a theoretical framework to inform the search for habitable planets and life beyond our Solar System: PI: Victoria S. Meadows
- \$1.85 million from the National Science Foundation for the development of sustainable chemistries and solution-processing methods that yield high-efficiency low-cost solar cells from Earth abundant resources. PI: Hugh W. Hillhouse
- \$1.13 million from the Bill & Melinda Gates Foundation for development of a self-service community impact assessment patron survey and advocacy tools for public access technology products and services offered by public libraries across the United States. PI: Mike Crandall

Despite federal funding challenges, the UW continues to gain strength as we strategically focus our resources on supporting the research enterprise. The effect has been increased competitiveness and collaboration resulting in quality research with impact, and an investment in the future of the UW and our world. I am pleased to present the Office of Research Annual Report for fiscal year 2013.

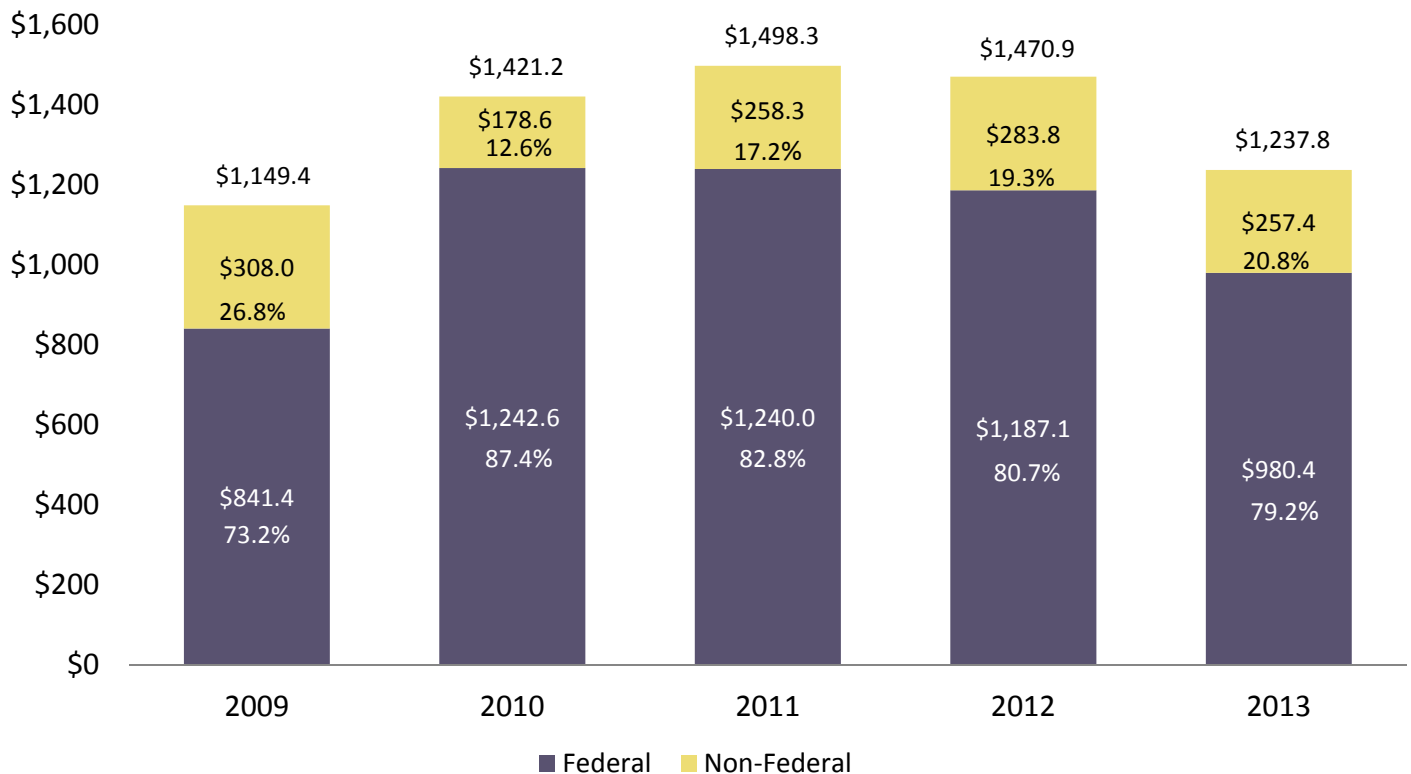
## Highlights: Summary of FY 2013 Awards and Expenditures

### Awards

During Fiscal Year 2013, the University requested \$4.256 billion and was awarded \$1.238 billion in grants and contracts, of which \$8 million was from ARRA. In comparison, the University received \$1.471 billion in Fiscal Year 2012, of which \$7 million was from ARRA.

FY 2013 federal awards totaled \$980 million (79% of the \$1.238 billion total) to support research, equipment, fellowships and traineeships, special programs of instruction, and service programs that support our region and the nation.

**Figure 1: Awards Originating from Federal and Non-Federal Awards, in Millions and Percent of Total Awarded, FY 2009 -2013**

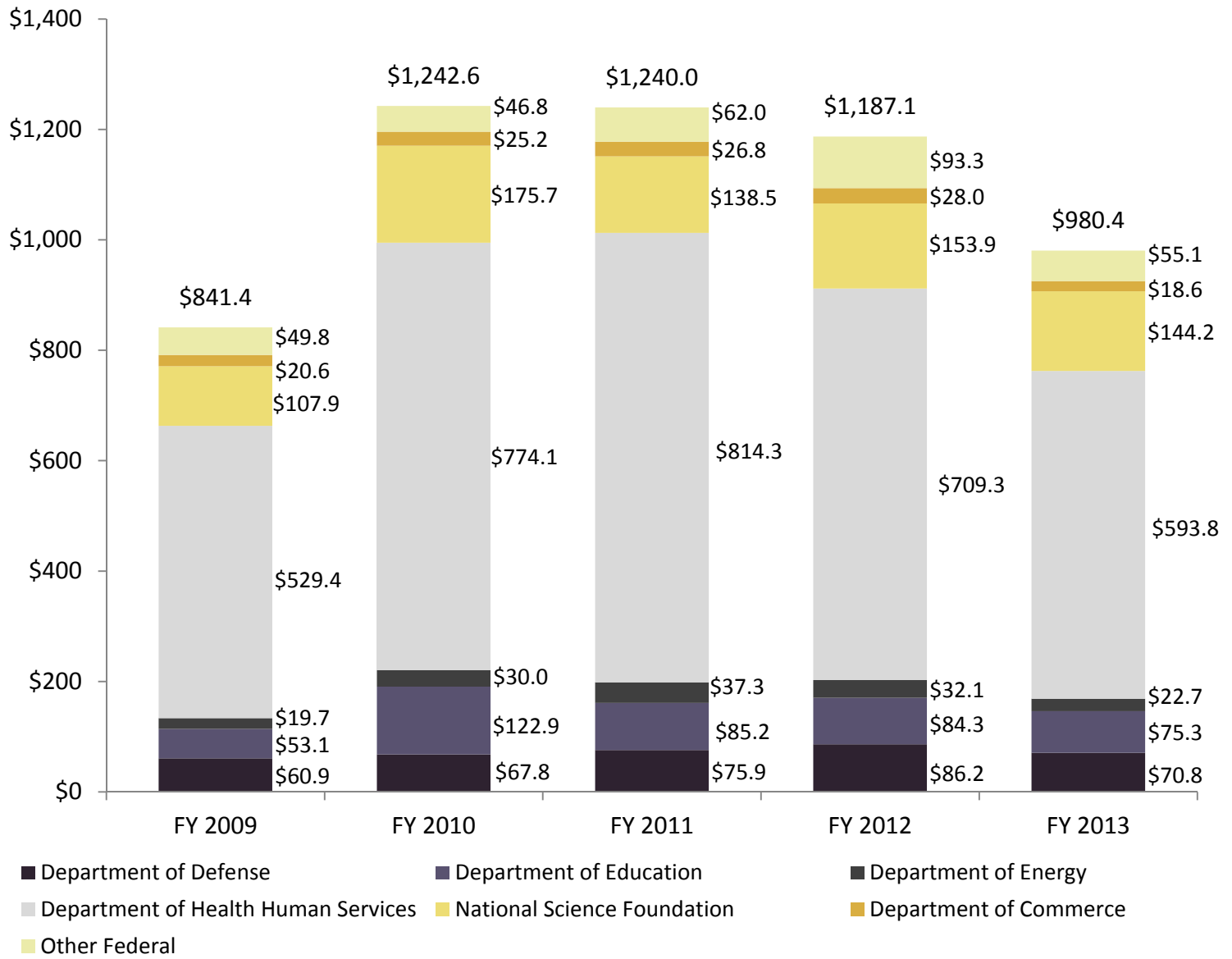


- The originating sponsor is the original source of funds. A direct sponsor can refer to a sponsor who is subcontracting funds to us from an originating sponsor. This schedule shows awards by originating sponsor.
- From 2010 – 2011, additional federal funding under ARRA accounts for the higher levels of funding.
- 2013 federal funding was decreased due to the timing of sequestration. Federal sponsors held off funding awards until the end of the federal fiscal year 2013 (which is the beginning of UW's fiscal year 2014). In fact, UW's FY 2014 Q1 (i.e. the last quarter of the federal FY 2013), saw a 34% increase of federal funding.

## Awards: Federal Support

The FY 2013 federal awards total of \$980 million represents 79% the overall \$1.238 billion.

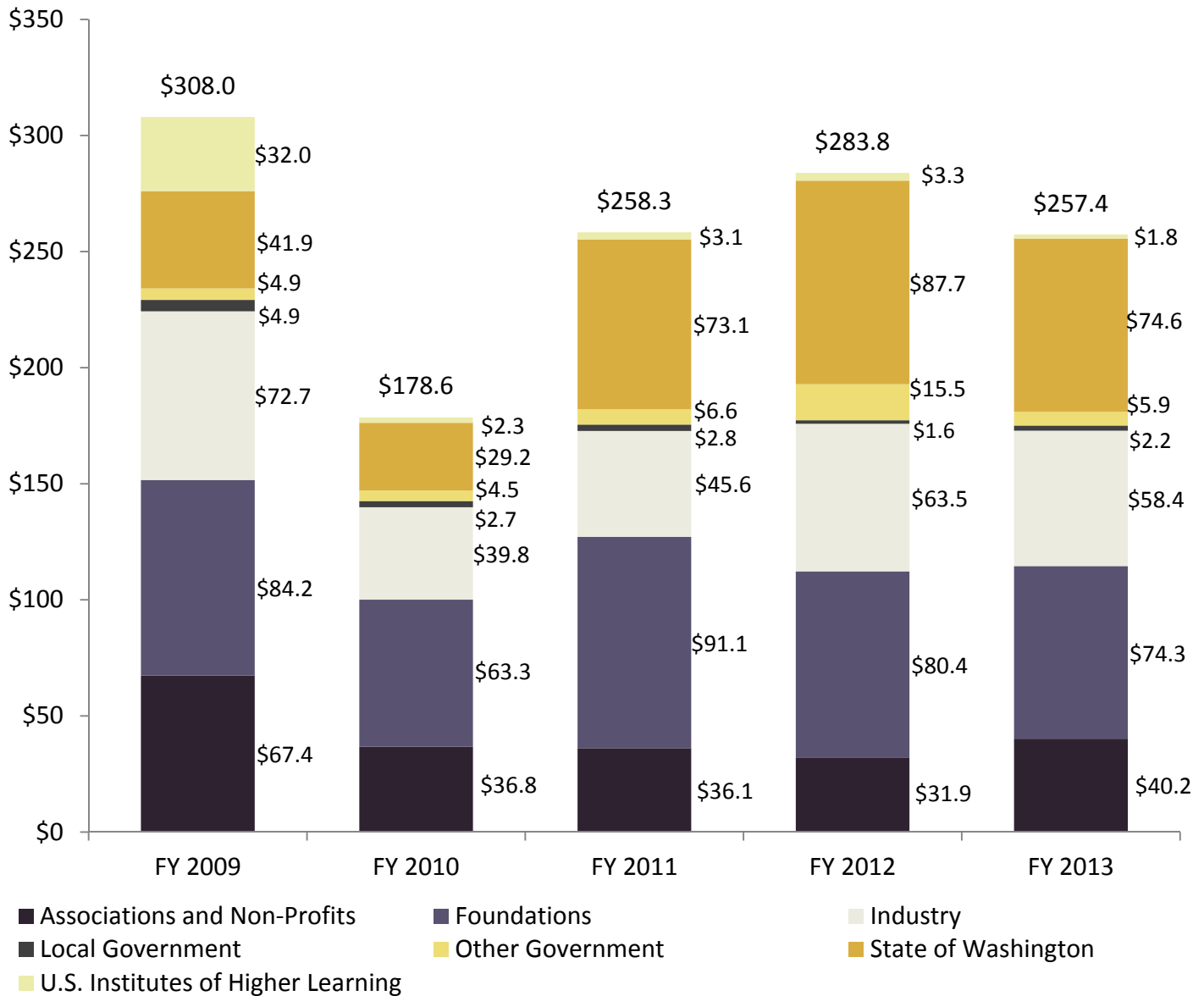
**Figure 2: Awards Originating from Federal Grant and Contract Awards by Year, in Millions, FY 2009 - 2013**



### Awards: Non-Federal Support

The FY 2013 non-federal awards total of \$257 million represents 21% of the overall \$1.238 billion.

**Figure 3: Awards Originating from Non-Federal Grant and Contract Awards by Year, in Millions, FY 2009 - 2013**



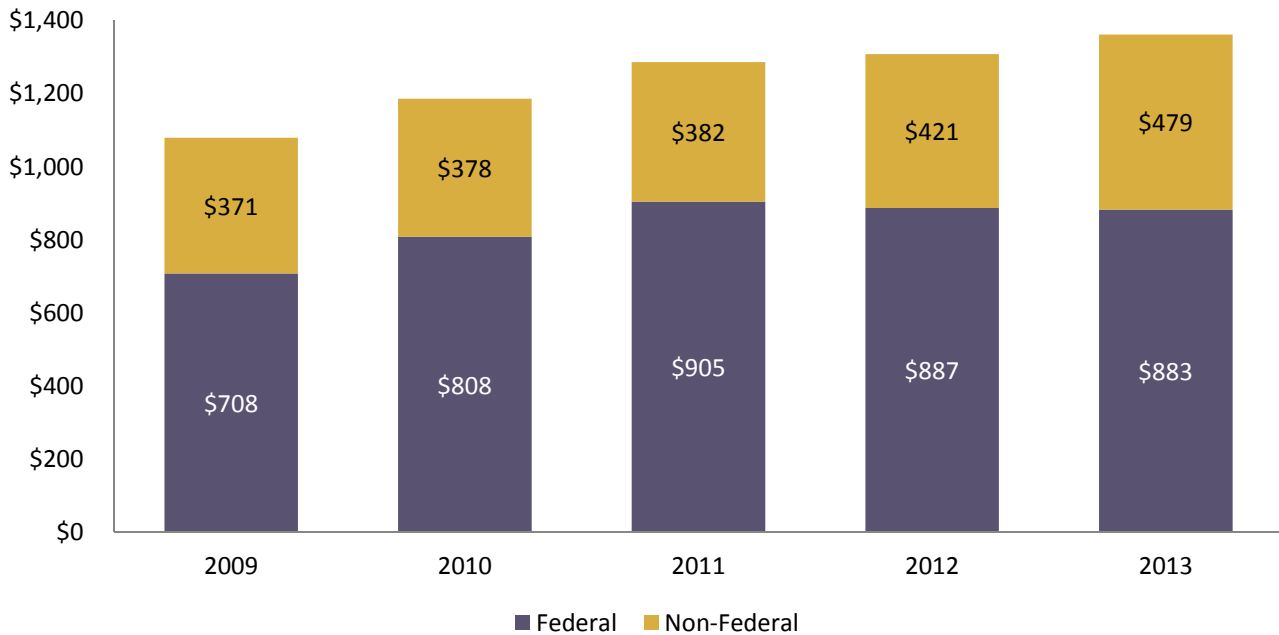
As in the past, the FY 2013 non-federal support includes awards from associations and non-profit organizations, foundations, local and other state governments, U.S. institutions of higher learning, and private industry. The UW has been reaching out to expand on collaborative endeavors by

partnering with regional and international industries in anticipation that these relationships will lead to revitalized growth. Increased support from the UW Center for Commercialization will help in this effort.

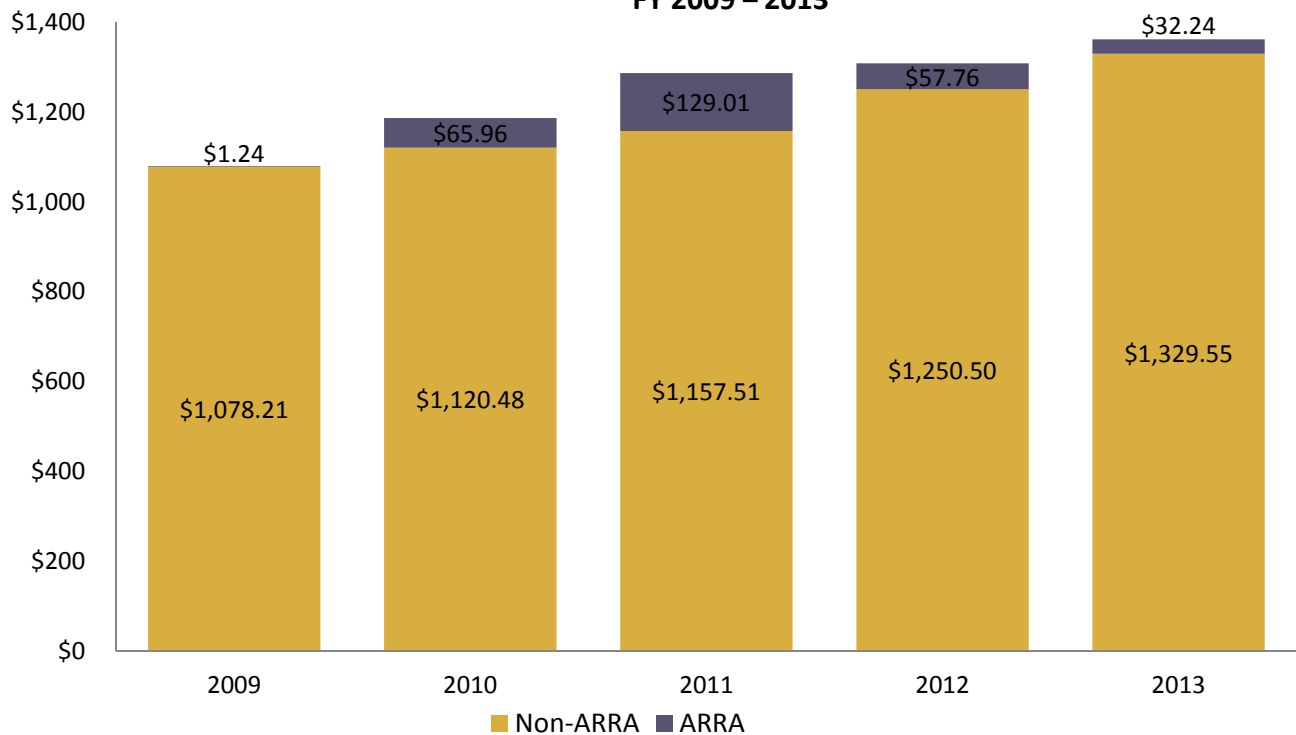
## Expenditures

**Figure 4: Federal and Non-Federal Direct Expenditures, in Millions, FY 2009 – 2013**



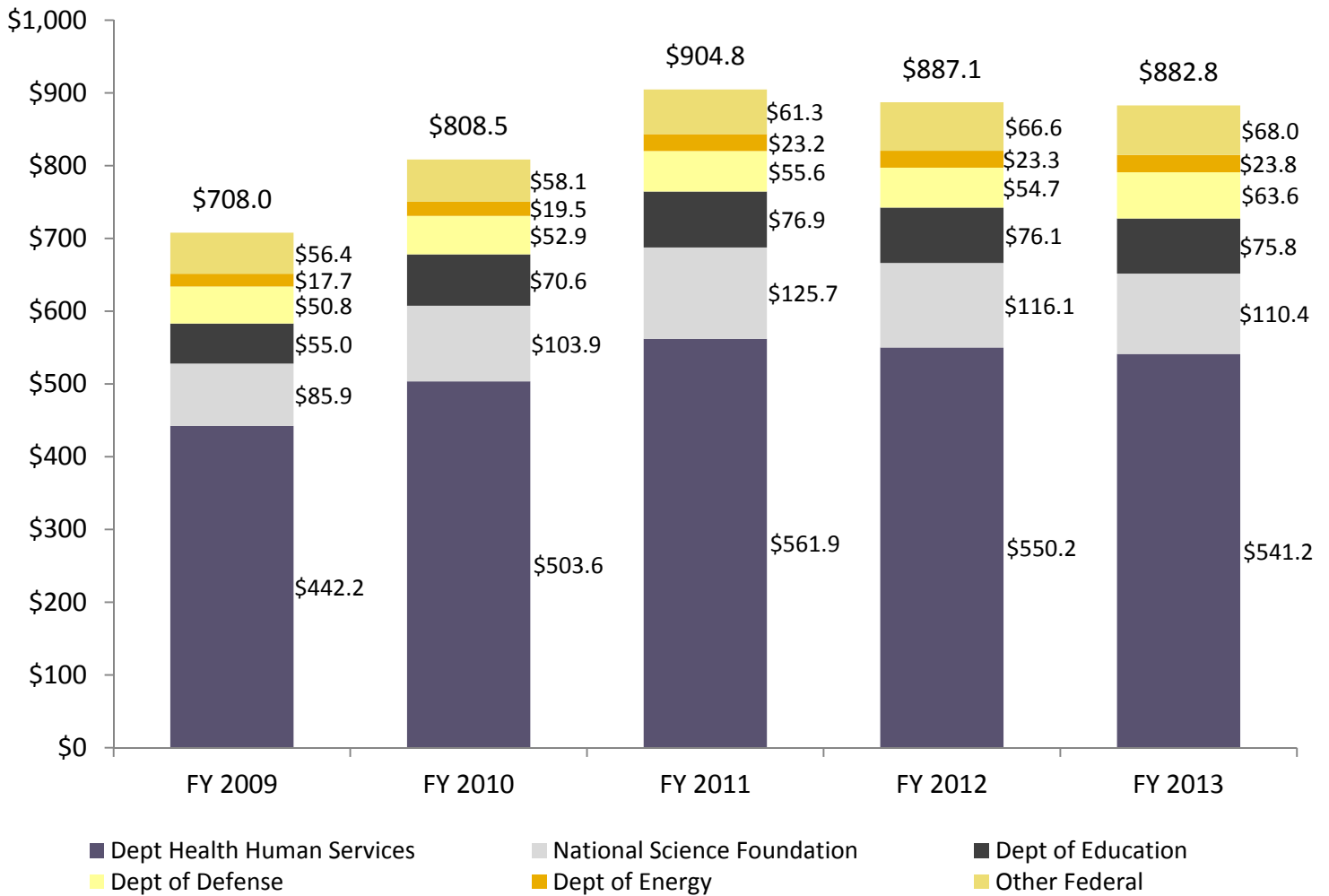
**Figure 5: ARRA and Non-ARRA Direct Expenditures, in Millions, FY 2009 – 2013**

Of the \$1.362 billion in expenditures, \$1.031 billion were federal funds, which represent 76% of all grant and contract expenditures.

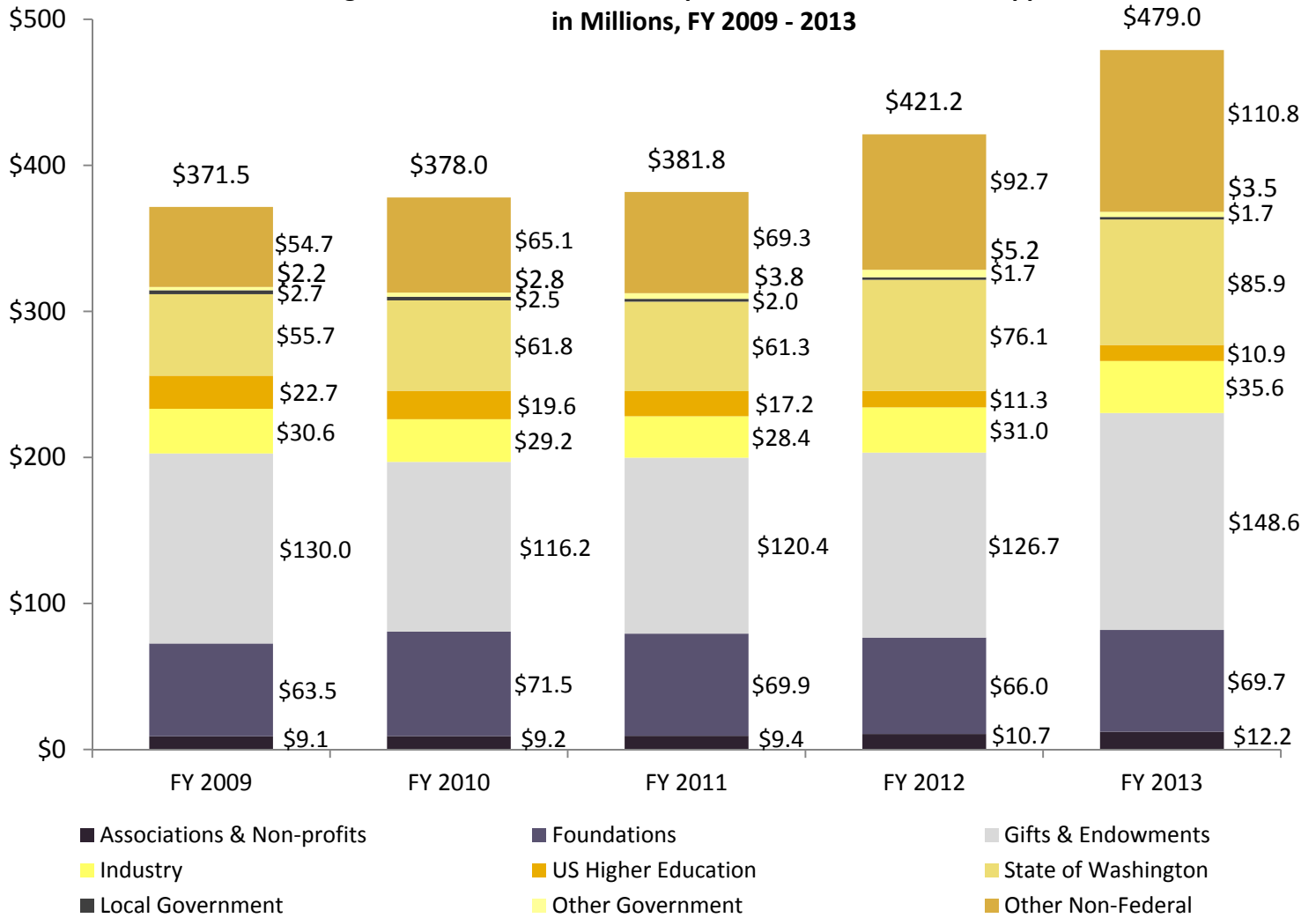
**Figure 6: Federal Direct Expenditures from External Support, in Millions, FY 2009 - 2013**



## Non-Federal Expenditures

Non-federal expenditures increased from \$295 million in FY 2012 to \$330 million in FY 2013 and represented 24% of total grant and contract expenditures.

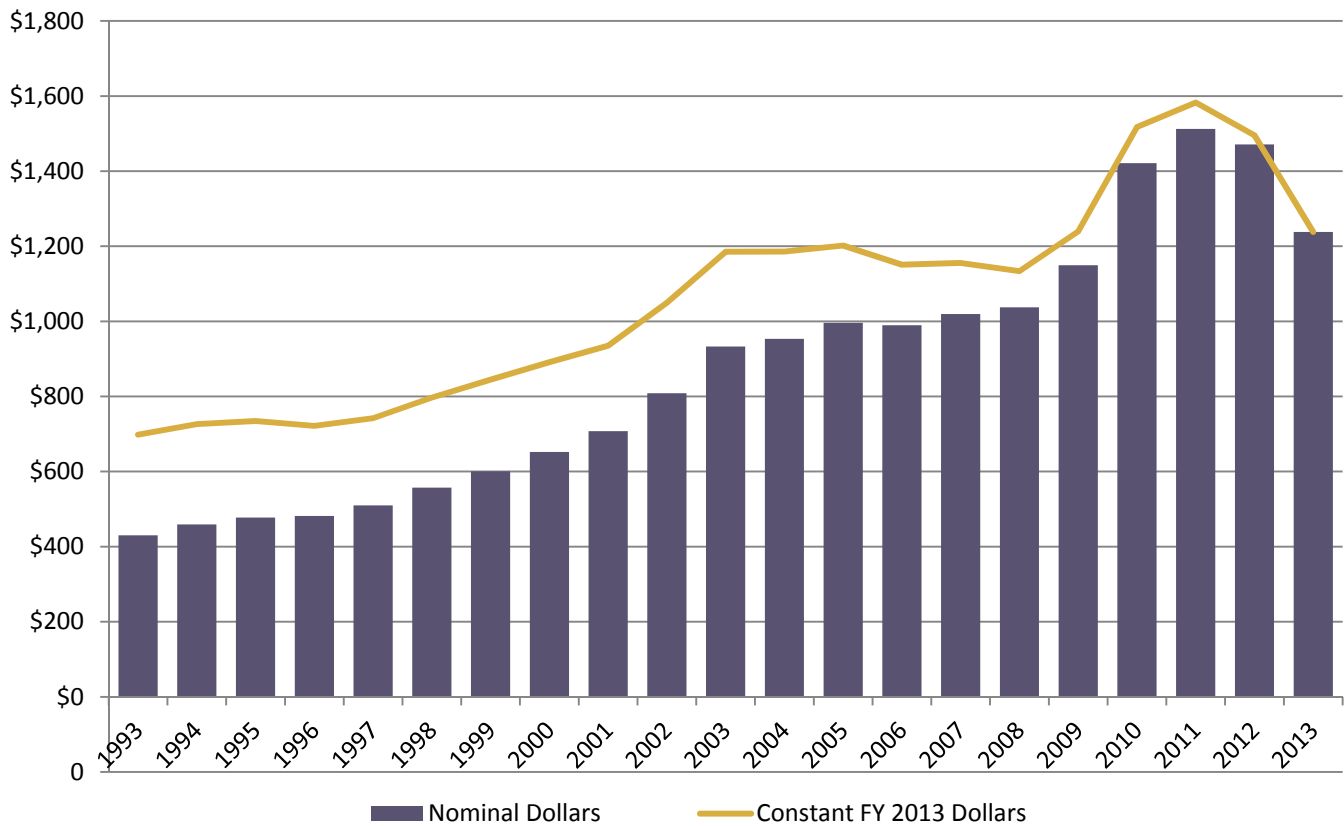

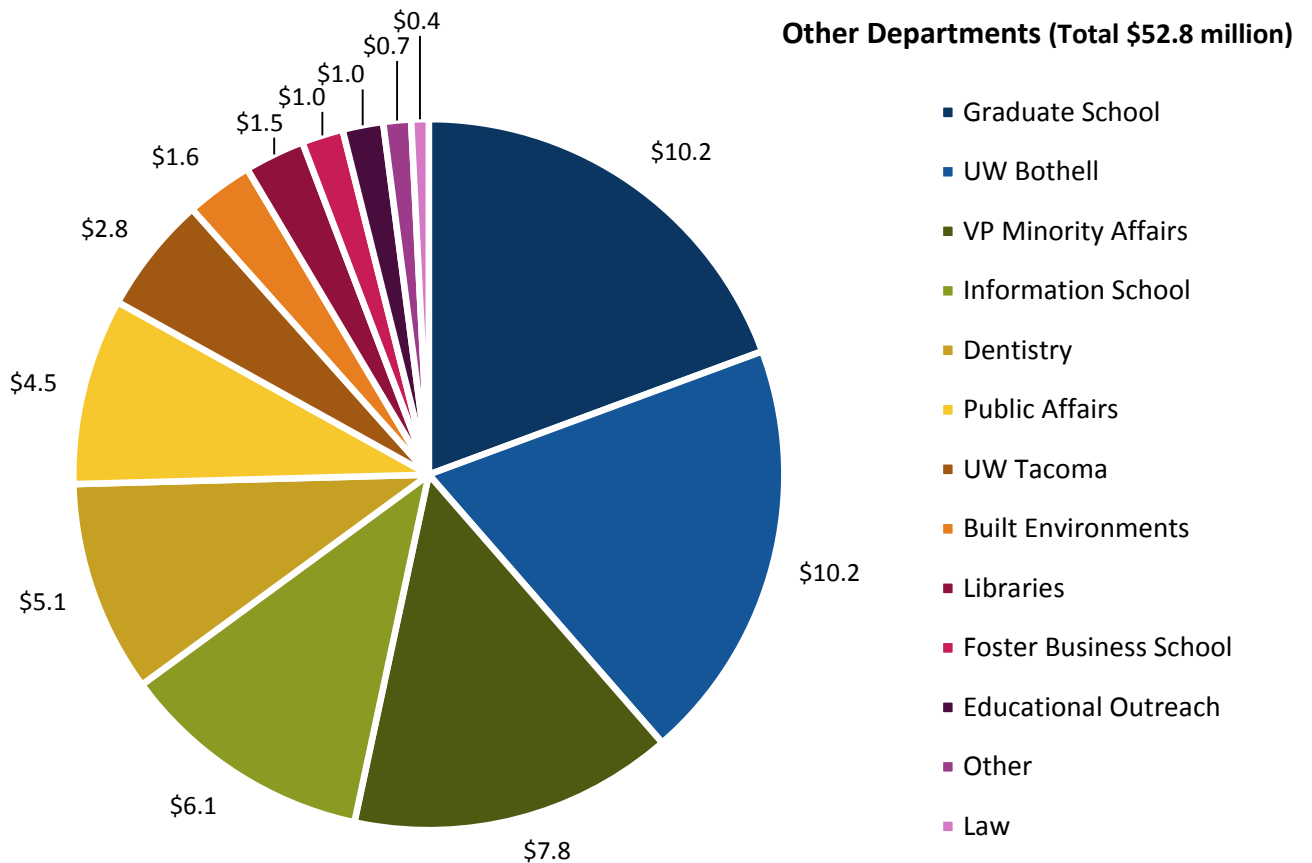

## Expenditures by Non-Federal Funding Source



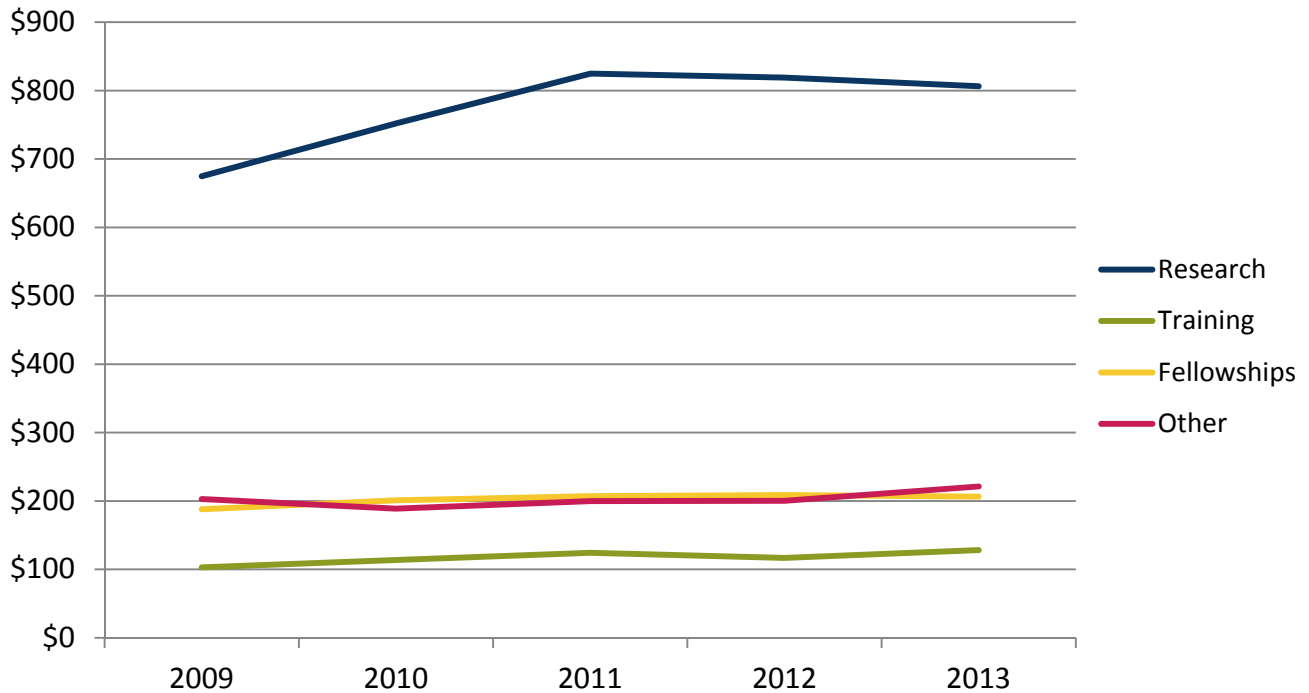

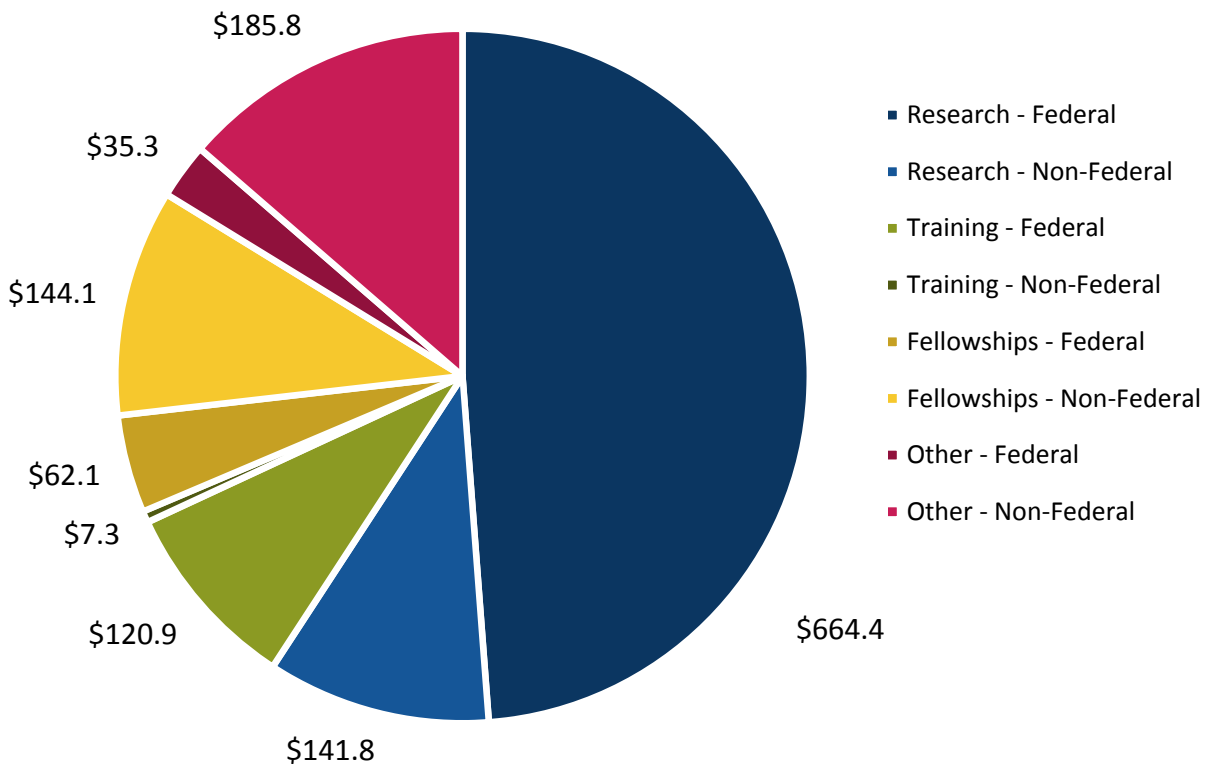

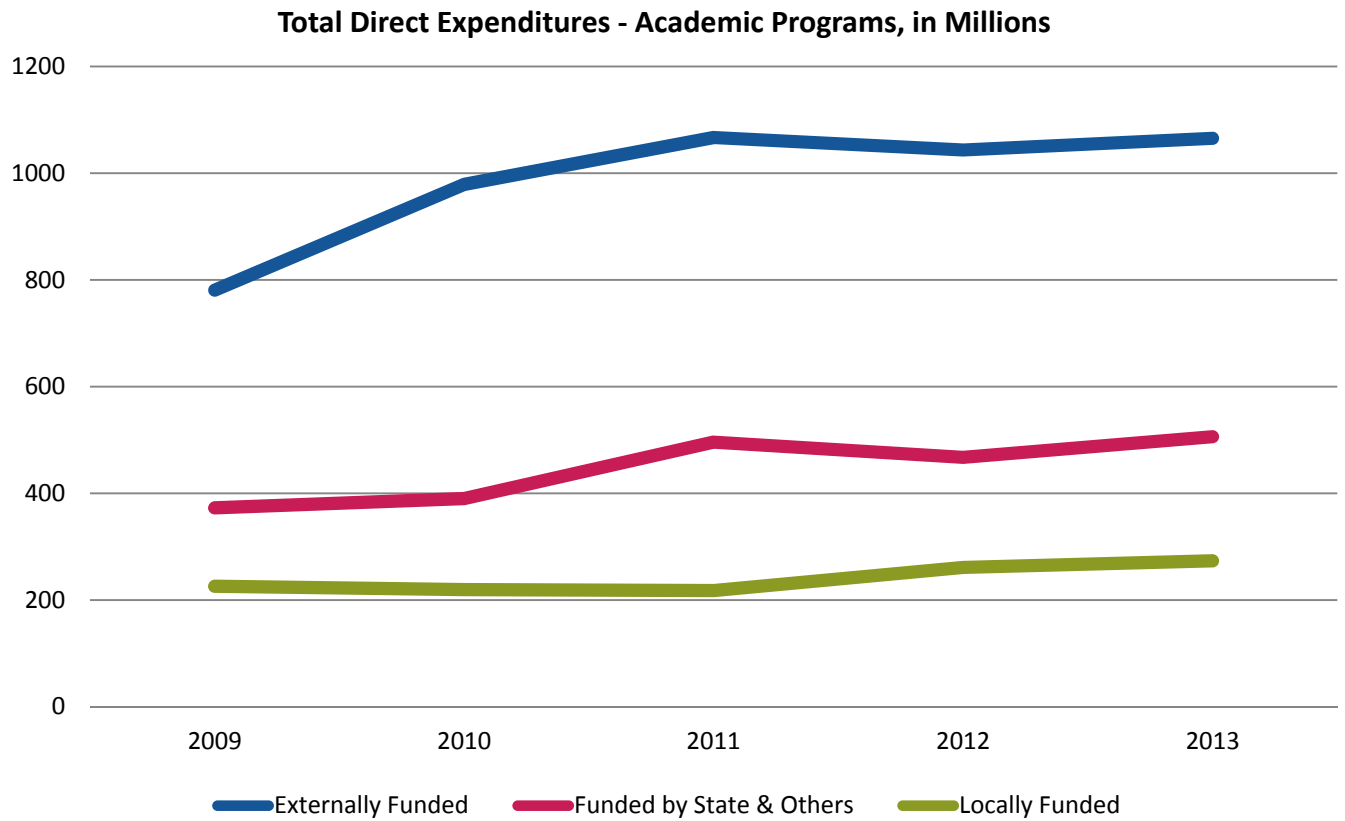

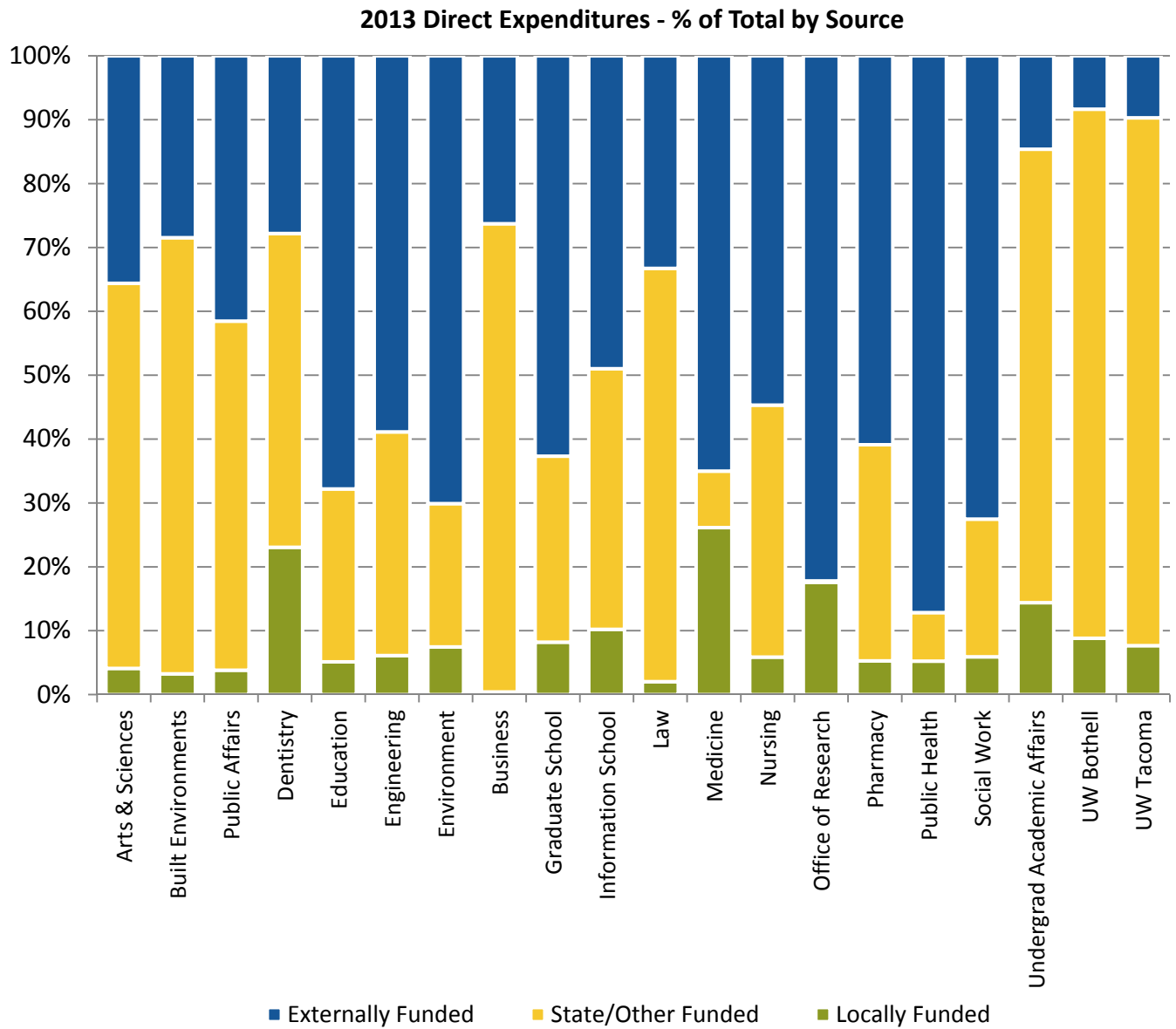

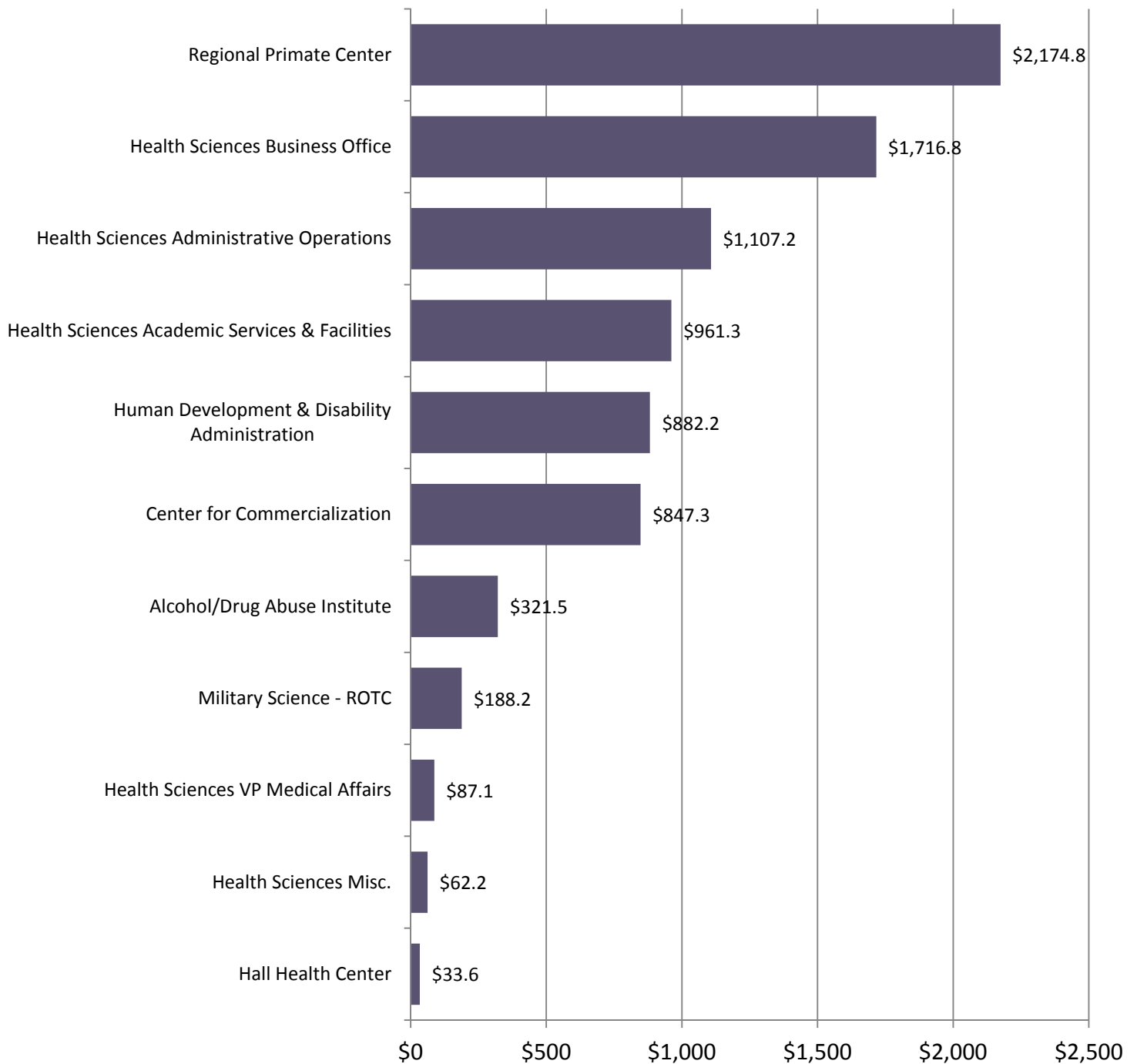

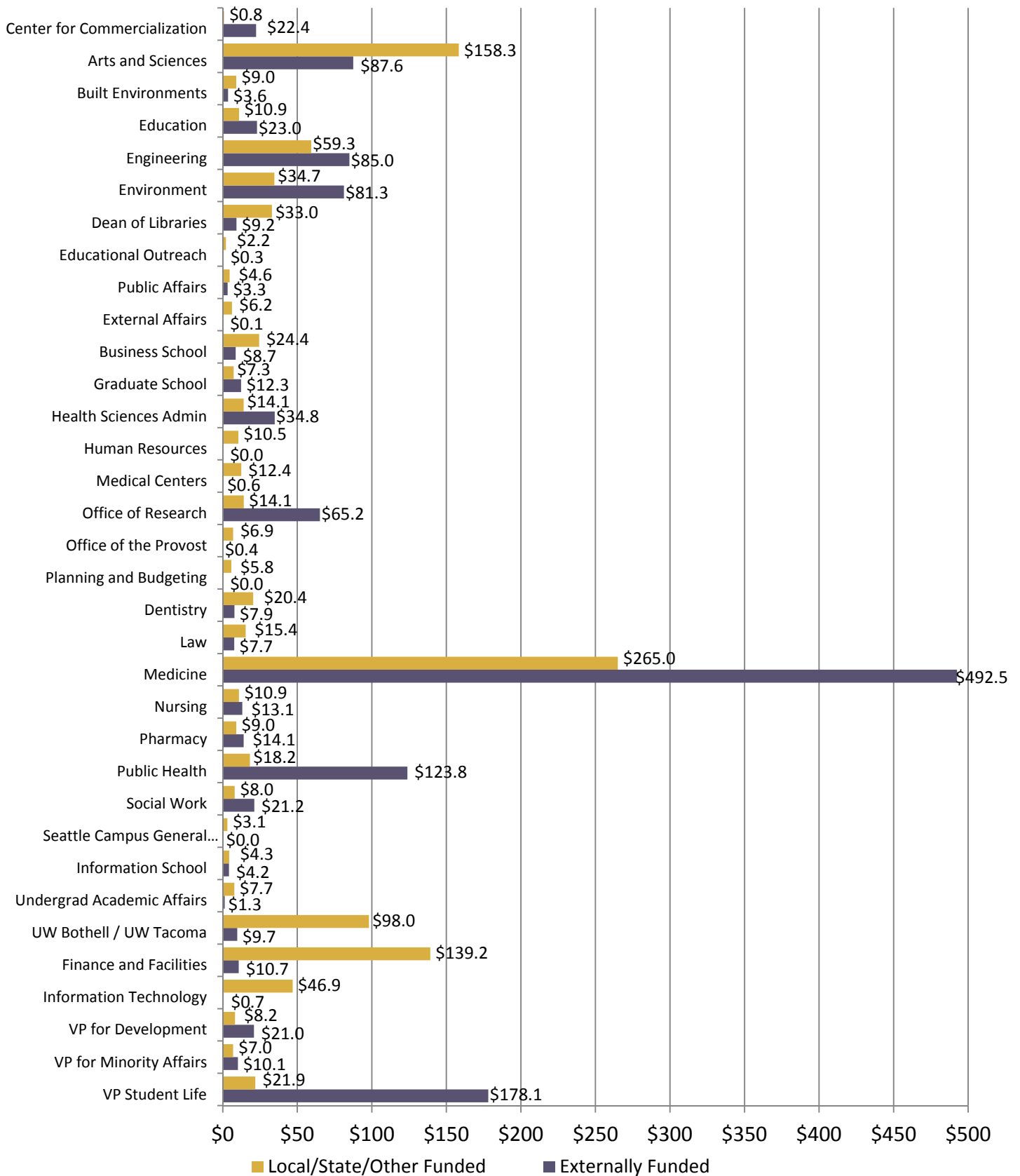

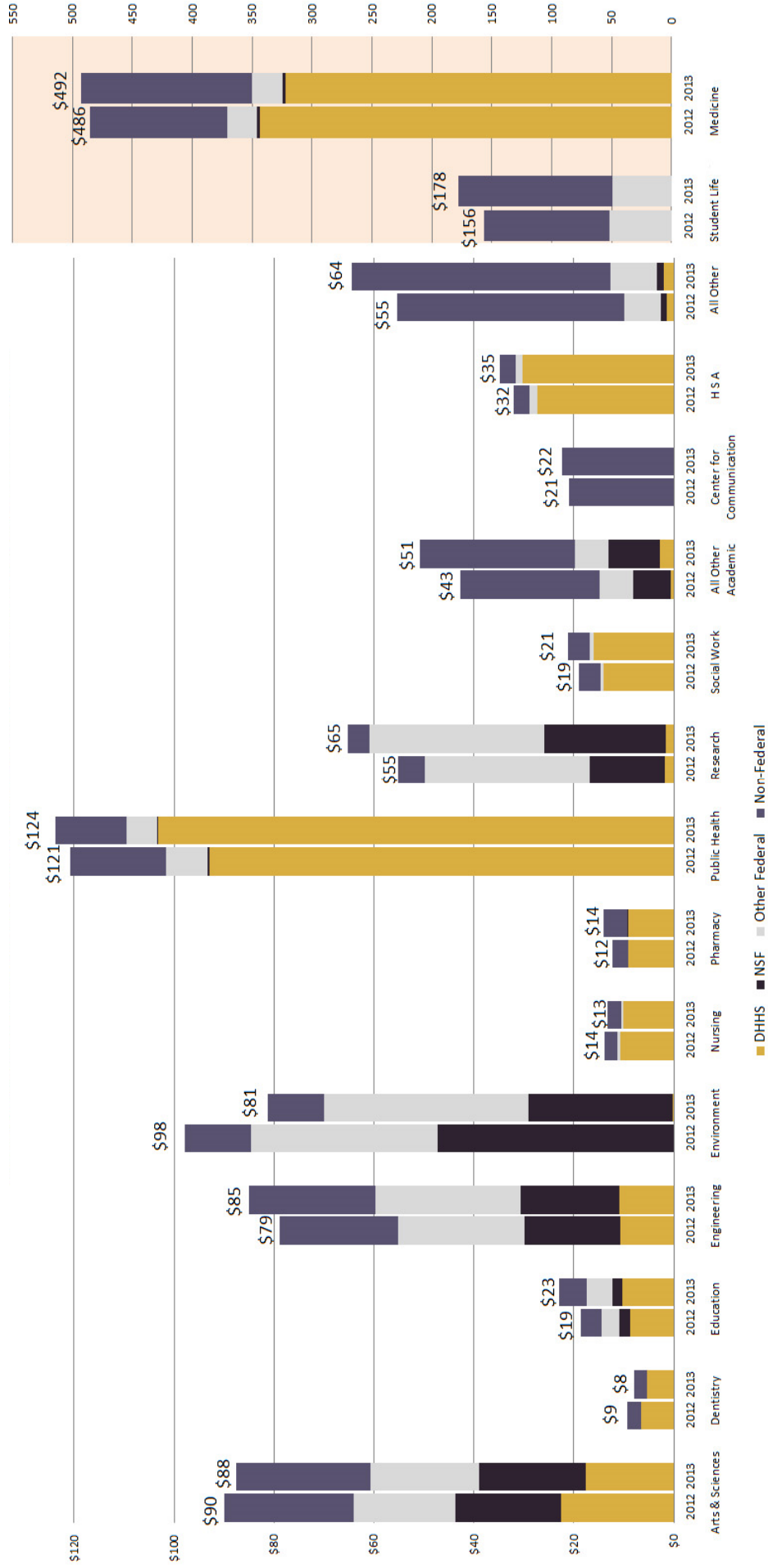

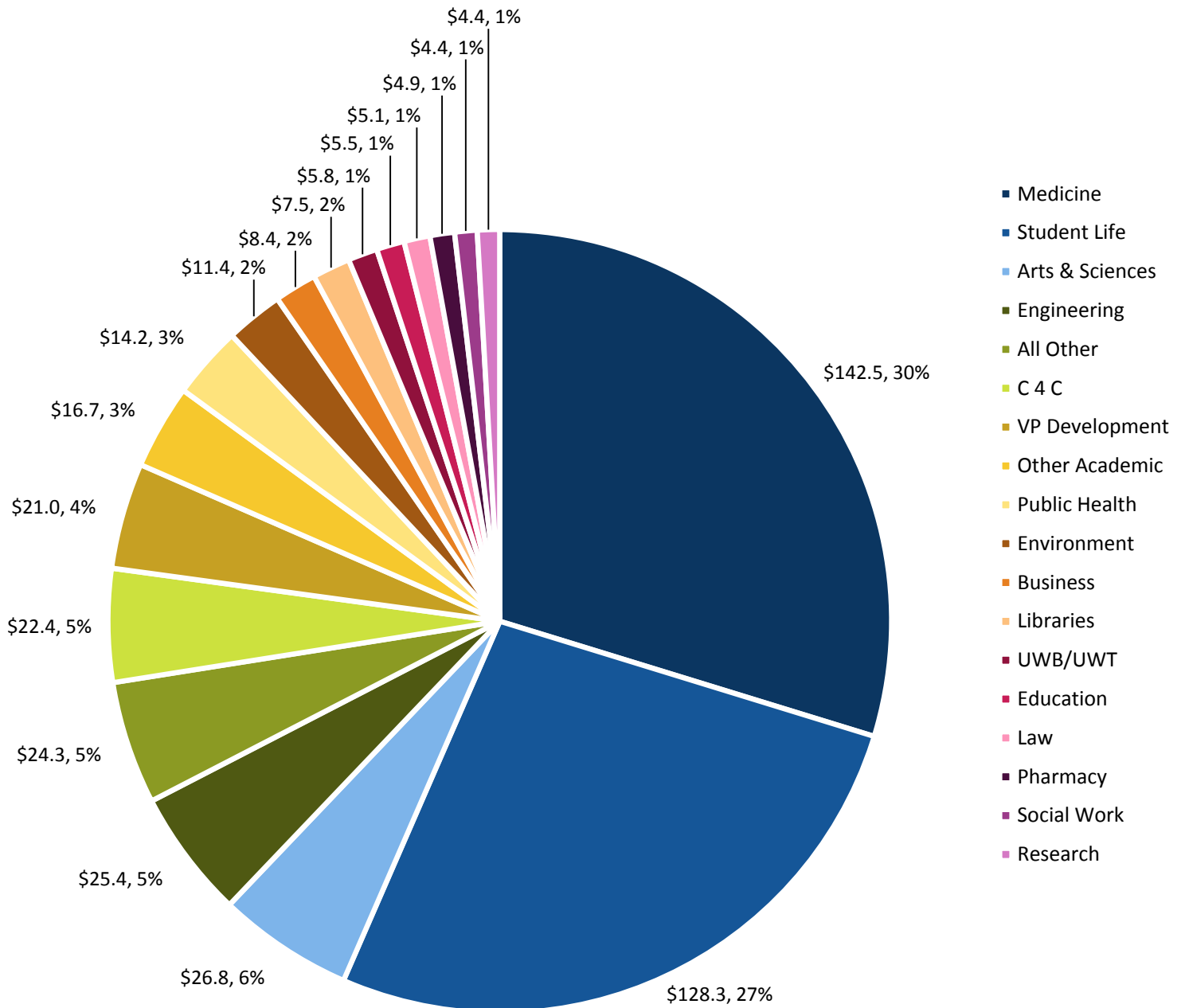

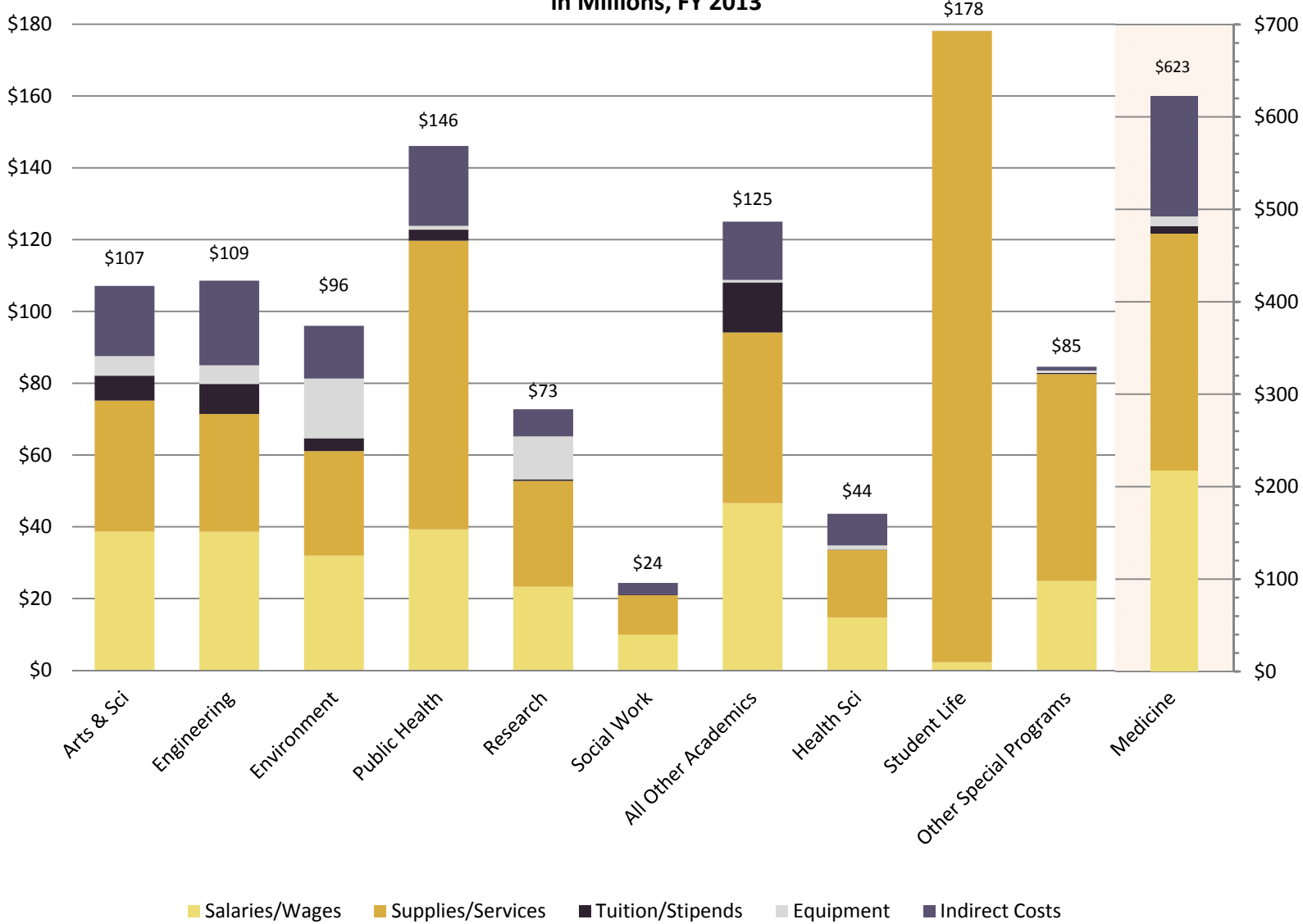

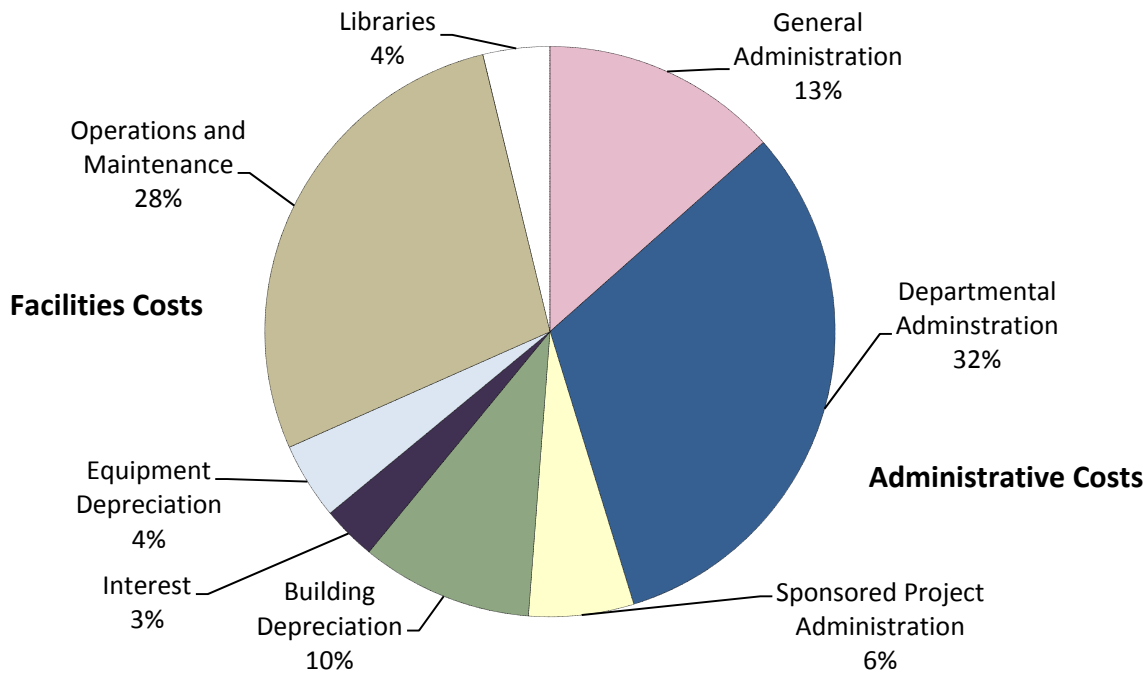

In a typical year, roughly half of the University's overhead for sponsored research maintains UW facilities supporting sponsored activity, and the other half supports central and departmental sponsored activity administration. About one third of the total F&A represents administration of sponsored activity managed within Departments, Schools, and Colleges. These funds are used by Deans and Chairs to support fiscal specialists, administrators, and other staff who assist faculty with sponsored activity—including grant proposal preparation and budget management.

The UW received approximately \$247 million in F&A costs reimbursements in FY 2013. The pie chart represents the proportion of actual overhead costs during the University's last F&A base year (FY 2008). Seventeen percent of the F&A funds represented central administrative costs used to help defray the costs of centralized research administration and compliance services, such as Research Accounting and Analysis, Human Resources, Payroll, Purchasing, Office of Research, Office of Sponsored Programs and the Human Subjects Division. Of the 51% spent on Facilities, a little more than half was spent on operations and maintenance of existing sponsored activity space,

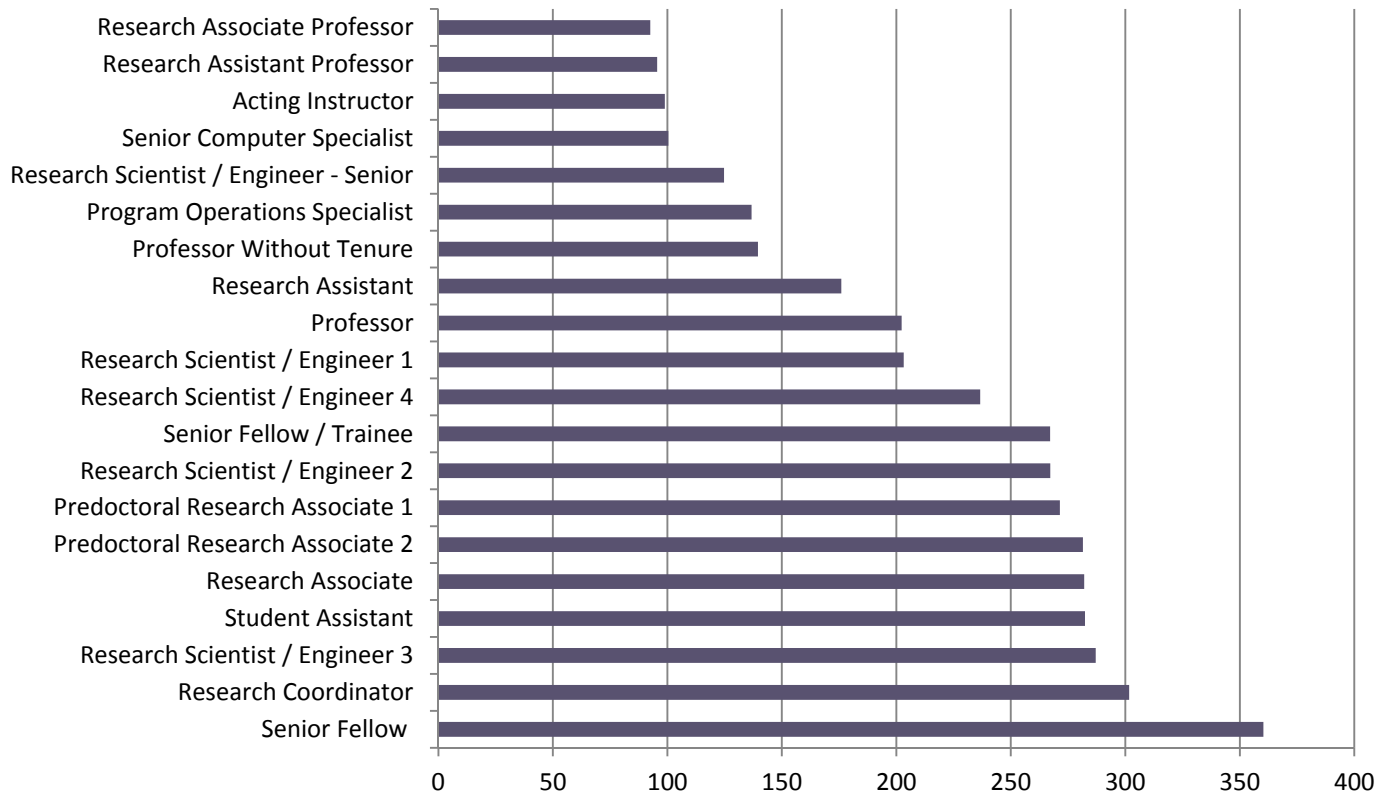
including paying for such costs as utilities, hazardous materials disposal, and janitorial services. The remainder paid for repairs and renovation of buildings, 'debt service' (interest) on new buildings, major equipment repair and replacement, and support for the libraries.

The PI's school or college generally receives about one-third of F&A costs through the Indirect Cost Recovery (ICR) allocation. These funds are used at the discretion of the Dean and Chairs to support research in their units.

F&A cost reimbursements are related to University expenditures. When the UW develops its budget for a biennium, it starts with an estimate of the total revenues available for that biennium, including State funding, tuition, F&A cost reimbursement, and interest and investment income. All these funding sources are combined to pay the UW's operating expenses, including F&A costs related to research and other sponsored agreements.

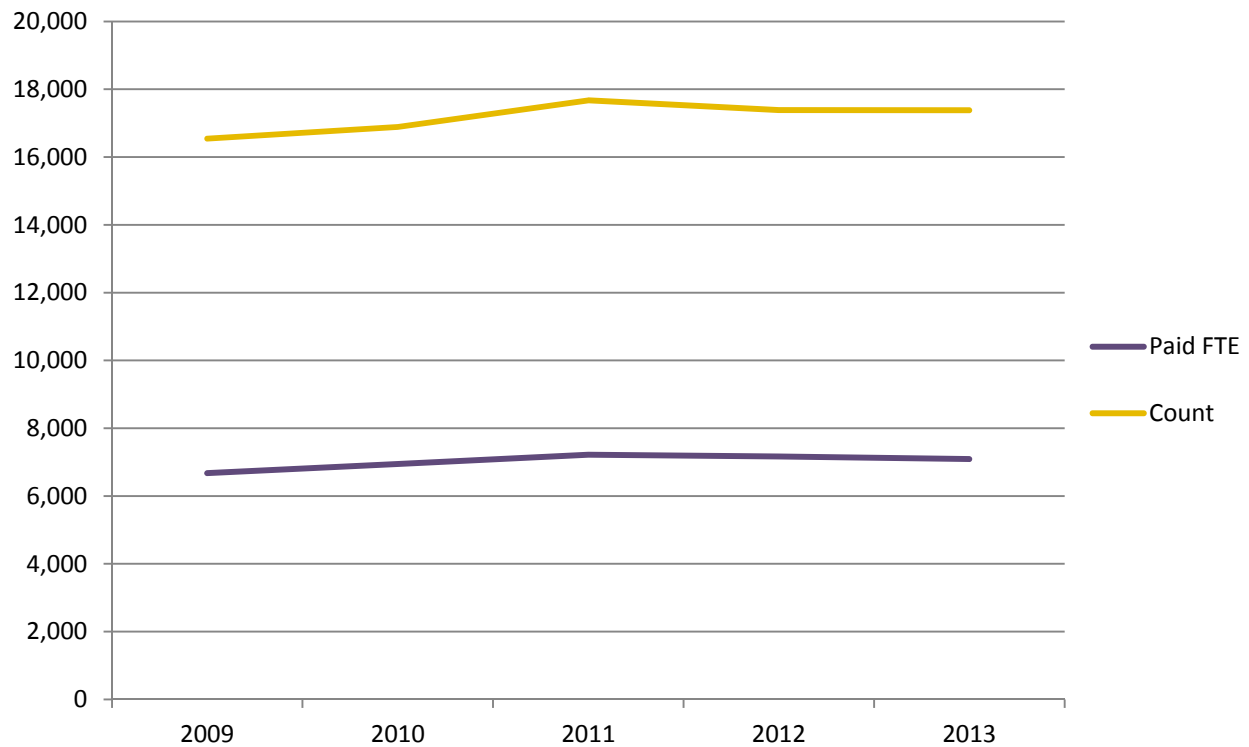

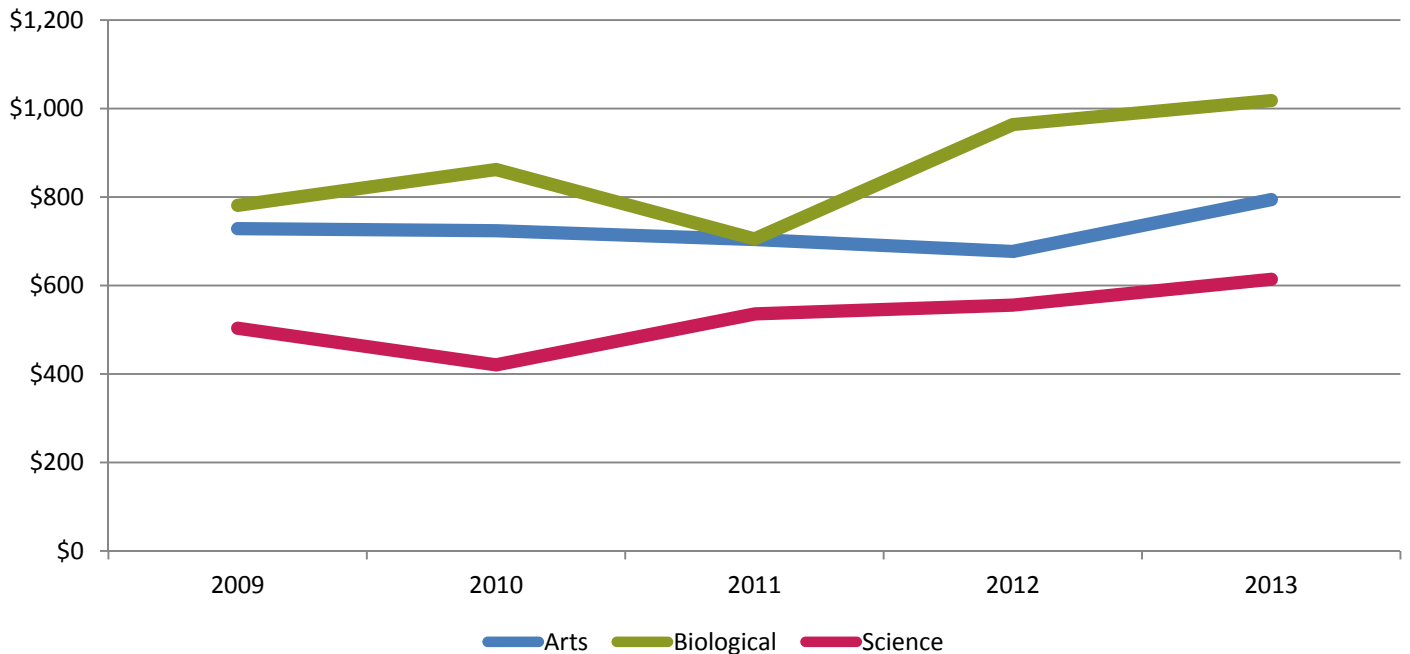
## Schedule 17: Royalty Research Fund Awards January 2009 – September 2013

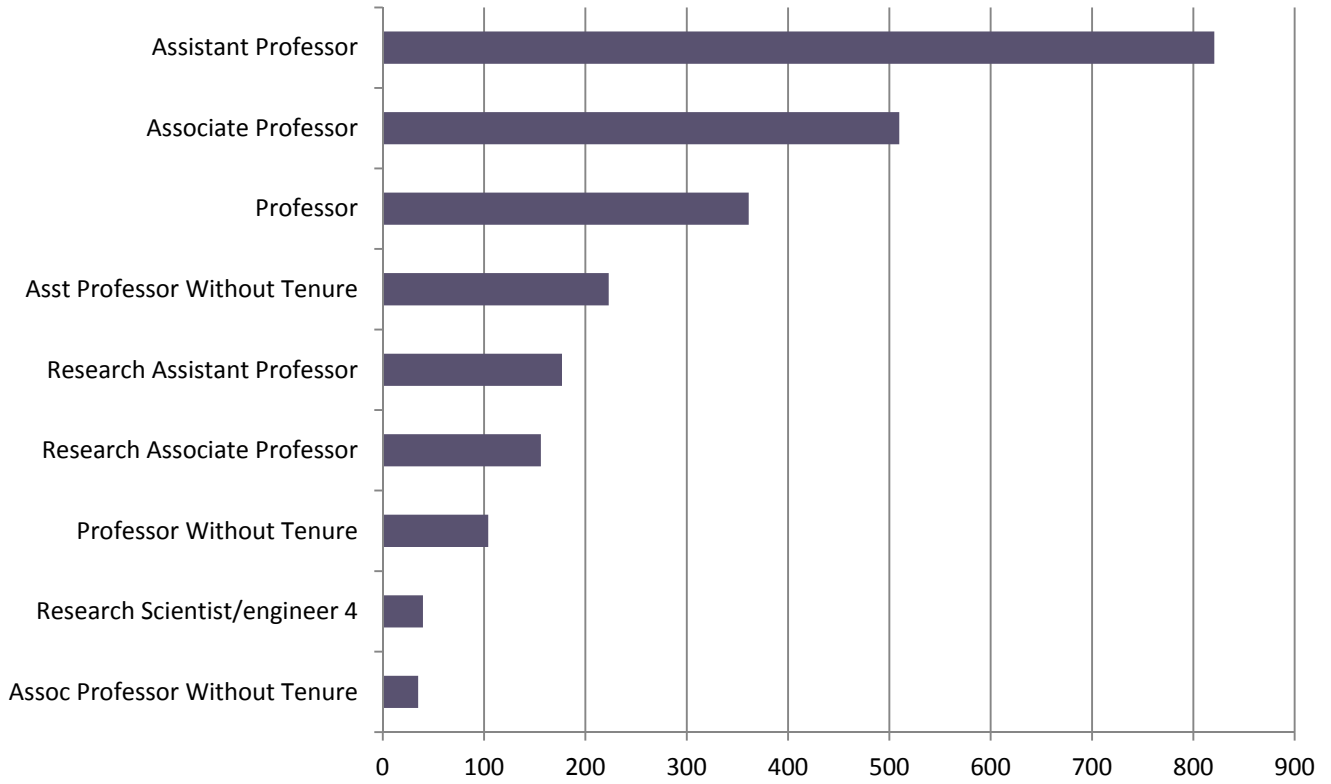
**RRF Awards 2009-2013, Requested and Awarded Amounts, in Thousands**

## Appendix 1: Notes and Definitions

The following notes and definitions may assist the reader in reviewing this report:

**1. Proposals:** Proposals for research projects are submitted by UW on behalf of principal investigators or program directors in response to sponsors' requests for proposals. They are the official requests for support, are generally competitive and do not guarantee funding. Proposals may be submitted to federal, state and other governmental agencies, not-for-profit foundations, private industry and business, and other academic institutions. The number of awards requested will significantly exceed the number of awards received in a given year.

**2. Awards:** Awards are received by the University in response to submitted proposals. Rarely are projects funded without a formal request in the form of a proposal. Generally, awards are received either as grants or contracts and represent financial resources that have become available for covering the cost of research, service, or education and training. The Awards total also includes grants for student scholarships, fellowships and work study programs administered by the Vice President for Student Affairs. The award numbers do not include student loans, gifts to the UW or to the UW Foundation. Note: Award amounts for previous fiscal years may be adjusted to reflect data changes in the UW's System to Administer Grants Electronically (SAGE).

**3. Expenditures:** These represent completed financial transactions against the award funds. Generally, the total grant and contract expenditures for a given fiscal year will be reasonably related to the total grant and contract awards in the preceding year or two. The term direct expenditures as used in this report covers only those costs incurred in direct support of the specific project. Indirect Costs or Facilities and Administrative (F&A) costs are those incurred centrally by the University as reimbursement for centrally expended funds in support of the externally sponsored project. F&A costs in no way include any profit or revenue over expenses but are the real costs of supporting the research effort that are not specifically identified for each project (for example, heat, electricity and water). Our standard rates are negotiated with DHHS.

**4. International Support:** A significant proportion of the awards and expenditures include support for research, training programs, fellowships, conferences, capacity building and other special purposes in the global arena. Of particular significance is the growth in the University's awards for international research and training. With the development of the Global Support Project, the UW has become a national leader in establishing the infrastructure necessary to carry out global projects. The UW, under the auspices of the Global Support Project, established *UWorld*, the foundation that enables UW to carry out significant programs in countries around the globe and has attained international recognition for its administrative support of global research and service. The UW also receives awards and sub-awards from international sponsors in countries around the world.

**5. Centers or Institutes:** The University has many departmental, interdepartmental, interschool and centrally administered research centers and institutes. These entities assist the University in carrying out its teaching, research, and public service missions; they are especially valuable in facilitating and supporting interdisciplinary research. The award and expenditure schedules in this report include sponsored programs at centers and institutes throughout the University but their activities are not specifically identified by unit in this report. In some cases, direct funding to a center or institute is shown under the heading *Special Programs*. But in many instances, awards and expenditures reported under the regular academic departments are related to one or more of the University's centers or institutes.

**6. Proposal and Award Data:** These were extracted from the Office of Sponsored Programs (OSP) database and the Grant and Contracts Accounting (GCA) database. Data related to the Awards and Expenditures schedules were provided by the Grant and Contract Accounting Office.

**7. Clinical Trial Data:** In support of the UW mission to carry out research and service to enhance quality of life, UW participates in national and international clinical trials. These trials are carried out under Institutional Review Board (IRB) approval and are closely monitored by UW compliance offices to ensure protection of human participants in the trials.

**8. Gift Funds:** Philanthropic funding from corporate, non-profit and individuals in support discovery, learning, athletics and UW infrastructure and special programs are not included in the proposal and award data but are included in expenditures.

### Graphs and Schedules

The Schedules in this report include data on 1) Proposals submitted, 2) Awards received, and 3) Expenditures made against the awards. The Office of Research and the Grants and Contracts Accounting Office track and report on the data relating to proposal submission and awards. UW Grant and Contract Accounting provides data on post-award expenditures.

It is important to note that schedules reporting the award data represent only funds received by the UW through the sponsored projects office and the financial aid office. Sponsored Project awards are independent of funds received by the University through legislative appropriations for its core educational mission and independent of philanthropic gifts received from donors. However, the third set of schedules included in this report, those representing expenditures, does generally include philanthropic gifts and some research-specific direct appropriations from the state of Washington. The effect is that the expenditure data reflects a greater amount of activity relating to research, service and education, including gifts supported by organizations external to the UW. The ratio of amount of awards to expenditures cannot be calculated based on this data; however, the UW carefully monitors expenditure rates in response to federal directives to expend in a consistent manner. Detailed reports on the philanthropic awards that support the research activities included in the expenditure report are provided by the Office of Advancement in their annual report.
